The ASEAN Secretariat

The ASEAN Secretariat was set up in February 1976 by the Foreign Ministers of ASEAN. It was then housed at the Department of Foreign Affairs of Indonesia in Jakarta. The existing ASEAN Secretariat at 70A Jalan Sisingamangaraja, Jakarta was established and officiated in 1981 by the then President of Indonesia, H.E. Soeharto. The ASEAN Secretariat's basic function is to provide for greater efficiency in the coordination of ASEAN organs and for more effective implementation of ASEAN projects and activities. The ASEAN Secretariat's vision is that by 2015, it will be the nerve centre of a strong and confident ASEAN Community that is globally respected for acting in full compliance with its Charter and in the best interest of its people. The ASEAN Secretariat's mission is to initiate, facilitate and coordinate ASEAN stakeholder collaboration in realising the purposes and principles of ASEAN as reflected in the ASEAN Charter.

ASEAN Centre for Energy (ACE)

ACE is an intergovernmental organization established by Brunei, Cambodia, Indonesia, Laos, Malaysia, Myanmar, Philippines, Singapore, Thailand and Vietnam. It is guided by Governing Council composed of the Senior Officials on energy of the ASEAN countries and a representative from the ASEAN Secretariat. Core funding is provided by an Energy Endowment Fund established from equal contributions of the ten member countries and managed by a private fund manager.

Chulalongkorn University

Chulalongkorn University is aware of the importance of ASEAN in the Southeastern Region of Asia and its role in the world community. Therefore, it has established a foundation for ASEAN studies and has promoted collaboration with outside communities in the government and private sectors and the people's sector in Thailand as well as in rest of the Southeastern Asian Region. The duties of the center are to coordinate work related to ASEAN Studies within the university, to build up the competency of the faculties, colleges and institutes to create a body of knowledge, to develop an in-depth collaborative academic network related to ASEAN issues and to disseminate the knowledge about ASEAN through extensive activities. Energy Research Institute (ERI)

Dr. Hardiv is currently a Chairman of Indonesian National Committee- World Energy Council (KNI-WEC), and advisor to the National Development Planning Agency on Indonesia Climate Change Sectoral Roadmap for Mitigation Actions. The WEC is a global, non-profit, multi-energy organization, dedicated to promoting the sustainable supply and use of energy for the greatest benefit of all, established in 1923.

He was Senior Advisor to the BoD, Indonesia State Electricity Corporation – PT PLN (Persero) from 2003 to 2009, and Director of Planning from 1998 to 1999 and from 2001 to 2003, responsible for corporate plan, power system expansion planning, analysis and evaluation of corporate performances as well as corporate information system. Prior to these, Hardiv was Head of Transmissions and Java-Bali Control Centre, responsible for power system operations and control, transmissions and substations system developments including SCADA and telecommunication system developments as well as its operation and maintenance, and energy transaction. He also conceptualized and led a comprehensive change management initiative to transform the organization into an efficient and autonomous business unit of PLN, and established an internal management performance monitoring system.

Member of Indonesian Delegation for the Conference of the Parties, the Subsidiary Body for Scientific and Technological Advice since 2004, the Ad Hoc Working Group on Further Commitments for Annex I Parties under the Kyoto Protocol since 2007, and the Ad-Hoc Working Group on Long-term Cooperative Action under the Convention since 2008 of the United Nations Framework Convention on Climate Change.

Since joining the university in 1992, he has been actively participating in research projects concerning mainly energy and environmental issues. Dr. Bundhit's main interests cover power system operation, as well as planning, energy policy and modeling. The first area covers optimal short-term power system operation and long-term power system planning, especially with application of probabilistic methods, whereas the later focuses on energy policy development based on the energy system modeling and simulations. He has a vast array of publications and contributions to books in these two areas, and has conducted numerous projects for the Ministries of Energy as well as public authorities. His recent research work includes Thailand Energy Outlook, and the Thailand Energy Master Plan Development for the Thailand Ministry of Energy. During his career, Dr. Bundhit also served as a Member of Board of Director, Metropolitan Electricity Authority (MEA), Thailand as well as the Board of Sub-committees, Energy Policy & Planning Office (2003, 2005).
